R. W. CRAWFORD, OF SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON 200,000 FEET OF SAW LOGS WITHOUT BRAND OR MARK WHICH WERE CUT IN SKAMANIA COUNTY, STATE OF WASHINGTON AND ARE NOW LYING IN THE TIMBER ABOUT ONE-HALF MILE SOUTHEAST OF THE MILL OF THE CARSON MILL & FLUME COMPANY, LOCATED ON BEAR CREEK, ABOUT SIX MILES NORTH-EAST OF CARSON, SKAMANIA COUNTY, WASHINGTON, AND ALSO A LIEN UPON 25,000 FEET OF LOGS IN THE MILL POND AT THE MILL OF THE SAID CARSON MILL & FLUME COMPANY LOCATED AS AFORESAID, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN CUTTING SAID LOGS; THAT THE NAME OF THE OWNER OR REPUTED OWNER IS CARSON MILL & FLUME COMPANY AND C. C. SHAY; THAT SAID CARSON MILL & FLUME COMPANY AND C. C. SHAY EMPLOYED CLAIMANT TO PERFORM SUCH LABOR AND RENDER ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT: THAT SAID CARSON MILL & FLUME COMPANY AGREED TO PAY CLAIMANT FOR SUCH LABOR AND ASSISTANCE THE SUM OF \$10.00 A DAY; THAT THE LABOR PERFORMED WAS THAT OF HAULING LOGS IN THE LOGGING CAMP OF SAID CARSON MILL & FLUME COMPANY AND C. C. SHAY; THAT SAID CONTRACT HAS BEEN FAIT (FULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF SAID CLAIMANT WHO PERFORMED LABOR UPON AND ASSISTED IN CUTTING SAID LOGS FOR THE PERIOD OF ABOUT SIXTEEN DAYS; THAT SAID LABOR AND ASSISTANCE WAS SO PERFORMED AND RENDERED UPON SAID LOGS BETWEEN THE 1ST DAY OF JULY, 1925 AND THE 17TH DAY OF JULY, 1925, AND THE RENDERING OF SAID SERVICES CEASED ON THE 17TH DAY OF JULY, 1925; AND THAT THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANT'S DEMAND FOR SAID SERVICES IS \$140.40; THAT NO PART THEREOF HAS BEEN PAID AND THERE IS NOW DUE AND REMAINING UNPAID THEREON AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS THE SUM OF \$140.40 IN WHICH AMOUNT CLAIMANT CLAIMS A LIEN UPON SAID LOGS; THAT SAID CLAIMANT ALSO CLAIMS A LIEN ON ALL SAW LOGS AND TIMBER PRODUCTS NOW OWNED BY SAID CARSON MILL & FLUME COMPANY AND C. C. SHAY, OF SAID COUNTY, TO SECURE THE PAYMENT FOR WORK AND LABOR PERFORMED IN OBTAINING OR SECURING SAID LOGS.
