NOTICE IS HEREBY GIVEN, THAT VIRGEL M. KELLOW OF SKAMANIA COUNTY, WASHINGTON, STATE OF WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF SAW LOGS, BEING ABOUT 755 LOGS OR 350 M. FT. IN QUANTITY, WHICH WERE CUT OR MANUFACTURED IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND ARE NOW LYING IN THE WOODS UPON THE LAND OWNED BY THE WIND RIVER LUMBER COMPANY, BEING THE SE $\frac{1}{4}$ OF SW $\frac{1}{4}$, SW $\frac{1}{4}$ OF SE $\frac{1}{4}$ OF SECTION 23 AND SE $\frac{1}{4}$ OF NE $\frac{1}{4}$ OF SEC. 26 TP. 3 N. R. 7 EAST OF W.M., BEING ALL THE LOGS LYING UPON THE SAID PROPERTY, AND 8 M FEET AT SMITH'S FERRY SLIP NEAR STEVENSON WASH. FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN MANUFACTURING SAID SAW LOGS, THAT THE NAME OF THE OWNER OR REPUTED OWNER IS J. J. BRUGGER; THAT HE EMPLOYED SAID CLAIMANT TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

TRUCK DRIVER AT 3.00 PER M. FOR 30,150 FT LOGS

THE SAID J. J. BRUGGER AGREED TO PAY THE SAID CLAIMANT FOR SUCH LABOR AND ASSISTANCE \$90.45; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF THE SAID CLAIMANT, WHO PERFORMED LABOR UPON AND ASSISTED IN MANUFACTURING SAID SAW LOGS FOR THE PERIOD OF DAYS; THAT SAID LABOR AND ASSISTANCE WERE SO PERFORMED AND RENDERED UPON SAID ^{SAW} LOGS, BETWEEN THE 1ST DAY OF JUNE 1925 AND THE 9TH DAY OF AUGUST 1925; AND THE RENDITION OF SAID SERVICE WAS CLOSED ON THE 9TH DAY OF AUGUST 1925, AND THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANT'S DEMAND FOR SAID SERVICE IS \$90.45; THAT NO PART THEREOF HAS BEEN PAID, AND THERE IS NOW DUE AND REMAINING UNPAID THEREON, AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS, THE SUM OF \$90.45, IN WHICH AMOUNT HE CLAIMS A LIEN UPON SAID SAW LOGS.

THE SAID CLAIMANT ALSO CLAIMS A LIEN UPON A QUANTITY OF SAW LOGS MANUFACTURED UPON THE LAND ABOVE DESCRIBED WITHIN SKAMANIA COUNTY, BELONGING TO THE SAID J. J. BRUGGER UPON WHICH CLAIMANT PERFORMED THE SAID LABOR AND ASSISTANCE IN CUTTING AND MANUFACTURING THE SAME AND WHICH WERE PLACED IN A RAFT OR BOOM AT THE FERRY SLIP BELONGING TO C. T. SMITH IN THE COLUMBIA RIVER WITHIN SAID COUNTY, AND WHICH WERE ELIOGNEED AND REMOVED THEREFROM BY THE WIND RIVER TIMBER COMPANY, A CORPORATION, ON OR ABOUT THE 29TH DAY OF AUGUST 1925, AND WITHIN THIRTY DAYS AFTER COMPLETION OF THE PERFORMANCE OF THE LABOR ABOVE SPECIFIED.

THE SAID CLAIMANT ALSO CLAIMS A LIEN ON ALL SAID LOGS NOW OWNED BY SAID J. J. BRUGGER OF SAID COUNTY TO SECURE PAYMENT OF THE WORK AND LABOR PERFORMED IN OBTAINING OR SECURING THE SAID LOGS, SPARS, PILES OR OTHER TIMBER, LUMBER OR SHINGLES HEREIN DESCRIBED.
