NOTICE IS HEREBY GIVEN, THAT B. F. REED OF SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF POLES, BEING ABOUT 125 IN NUMBER, WHICH WERE CUT AND MANUFACTURED IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND ARE NOW LYING AT OR NEAR THE FERRY LANDING AT THE FOOT OF RUSSEL STREET IN THE TOWN OF STEVENSON, SAID COUNTY, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN CUTTING AND MANUFACTURING SAID POLES;

THAT THE NAME OF THE OWNER OR REPUTED OWNER IS J. J. ERICKSON; THAT CLAIMANT WAS EMPLOYED BY SAID J. J. ERICKSON TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE AT THE RATE OF \$.50 PER HOUR; THAT SUCH LABOR AND WORK WAS FAITHFULLY PERFORMED BY CLAIMANT WHO PERFORMED SUCH LABOR UPON AND ASSISTED IN THE MANUFACTURE OF SAID POLES FOR A PERIOD OF NINE (9) DAYS, BEGINNING ON THE 29TH DAY OF OCTOBER 1925 AND ENDING ON THE 7TH DAY OF NOVEMBER 1925, AND THAT NOT MORE THAN 30 DAYS HAVE ELAPSED SINCE THE rendition OF SAID SERVICES WERE CLOSED; THAT THE CLAIMANT PERFORMED SUCH LABOR AND RENDERED SUCH SERVICES FOR A PERIOD OF 72 HOURS, DURING THE TIME AFORESAID, AND THAT THE AMOUNT DUE CLAIMANT THEREFOR IS THE SUM OF \$36.00, NO PART OF WHICH HAS BEEN PAID AND AGAINST WHICH THERE ARE NO JUST CREDITS OR OFFSETS.

WHEREFORE THE SAID B. F. REED CLAIMS A LIEN AGAINST THE SAID POLES AND ALSO CLAIMS A LIEN AGAINST ALL OF SAID POLES AND OTHER SAW LOGS AND TIMBER PRODUCTS OWNED BY THE SAID J. J. ERICKSON, WITHIN SAID COUNTY FOR THE WORK AND LABOR PERFORMED IN OBTAINING OR SECURING THE POLES HEREIN DESCRIBED.
