NOTICE IS HEREBY GIVEN THAT A. K. ANDREWS, CLAIMS A LIEN UPON THE PROPERTY HEREIN DESCRIBED AS FOLLOWS, TO-WIT:

ALL THE DONKEYS, LINES, LOCOMOTIVES, LOGGING TRUCKS, RAILS, AND ALL OTHER LOGGING EQUIPMENT, OWNED BY THE GREENLEAF LUMBER CO., AND USED BY THEM IN THEIR LOGGING OPERATIONS IN SKAMANIA COUNTY, STATE OF WASHINGTON, TOGETHER WITH ALL THE FRANCHISES, RIGHTS AND ACCOUNTS OF SAID GREENLEAF LUMBER CO.

ALSO ALL THE FOLLOWING DESCRIBED REAL PROPERTY TOGETHER WITH ALL TIMBER THEREON AS FOLLOWS, TO-WIT: WEST ONE HALF OF SEC. 6 TW N. R. 7 EAST OF W.M.; THE EAST ONE HALF OF THE NORTHWEST QUARTER OF SEC. 7 TW 2 N. R. 7 EAST OF W.M.; THE WEST ONE HALF OF THE SOUTHEAST QUARTER OF SECTION 7 TW 2 N. R. 7 EAST OF W.M.; THE WEST ONE HALF OF THE NORTHEAST ONE QUARTER AND THE NORTHWEST ONE QUARTER OF THE SOUTHEAST ONE QUARTER OF SEC. 18 TW 2 N. R. 7 EAST OF W.M.; ALL OF SEC 29, TW 3 N. THAT SAID LIEN IS CLAIMED FOR LABOR AND SERVICES RENDERED IN THE OPERATION OF THE LOGGING WORK CONDUCTED AND CARRIED ON BY THE SAID GREENLEAF LUMBER CO. IN CONNECTION WITH THE SAFTY WORK CARRIED ON IN CONNECTION THEREWITH.

THAT THE OWNER OR REPUTED OWNER OF ALL OF SAID PROPERTY SO DESCRIBED IS THE GREENLEAF LUMBER CO., AND THAT THE SAID GREENLEAF LUMBER CO. EMPLOYED SAID CLAIMANT TO PERFORM LABOR AND TO RENDER ASSISTANCE IN THE SAID LOGGING OPERATION UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT: THAT THE SAID A. K. ANDREWS WAS TO HAVE CHARGE OF AND CONDUCT THE SAFTY WORK OF THE SAID GREENLEAF LUMBER CO. AND THAT THE SAID GREENLEAF LUMBER CO WAS TO PAY THE SAID CLAIMANT THE SUM OF \$25.00 PER MONTH FOR SAID LABOR AND SERVICE SO RENDERED AND PERFORMED.

THAT THE SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH BY THE SAID CLAIMANT, WHO PERFORMED LABOR AND RENDERED ASSISTANCE IN SAID LOGGING OPERATION AS FOLLOWS, COMMENCED TO RENDER SAID LABOR AND RENDER SAID ASSISTANCE ON THE 1ST DAY OF JUNE, 1925 AND CEASED ON THE 30TH DAY OF SEPT., 1925 BOTH DATES INCLUSIVE; THAT THE TOTAL TIME OF SAID LABOR AND ASSISTANCE AMOUNTED TO FOUR MONTHS; THAT THE AMOUNT OF CLAIMANTS DEMAND FOR SUCH SERVICES IS \$100.00; THAT NO PART THEREOF HAS BEEN PAID, AND THAT THERE IS NOW DUE AND OWING TO SAID CLAIMANT AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS IS THE THE SUM OF \$100.00 IN WHICH SAID SUM THE CLAIMANT CLAIMS A LIEN UPON ALL THE PROPERTY HERETOFORE DESCRIBED; THAT NINETY DAYS HAVE NOT ELAPSED SINCE THE CESSATION OF SAID LABOR, AND THAT ALL OF SAID LABOR WAS PERFORMED WITHIN A PERIOD OF SIX MONTHS PRECEEDING THE FILING OF THIS LIEN.

NOTICE IS HEREBY GIVEN, THAT W. J. KELLEY AND FRED WALTHER, OF SKAMANIA COUNTY, STATE OF WASHINGTON, CLAIM A LIEN ON A QUANTITY OF SAW LOGS BEING ABOUT 75 THOUSAND FEET LOCATED AND NOW LYING IN THE WOODS ON THE FOLLOWING DESCRIBED TRACT OF LAND, TO-WIT:

SECTION 11, TOWNSHIP 3 NORTH, RANGE 9 E. W.M., IN SKAMANIA COUNTY, STATE OF WASHINGTON;

AND ALSO, UPON A QUANTITY OF SAW LOGS, BEING ABOUT 30 THOUSAND FEET, WHICH HAVE BEEN HAULED AND ARE NOW IN THE MILL POND OF THE BROUGHTON LUMBER COMPANY, LOCATED AT WILLARD, WASHINGTON, IN SKAMANIA COUNTY, STATE OF WASHINGTON.

THAT CLAIMANTS BEGAN CUTTING SAID LOGS AND PERFORMING LABOR UPON SAID LOGS, FOR WHICH THIS LIEN IS CLAIMED, ON THE 9TH DAY OF NOVEMBER, 1925, AND CEASED CUTTING SAID LOGS AND PERFORMING LABOR UPON SAID LOGS, ON THE 1ST DAY OF DECEMBER, 1925, THAT THE CLAIMANTS CLAIM THIS LIEN UPON THE LOGS AS ABOVE DESCRIBED FOR LABOR PERFORMED AND ASSISTANCE RENDERED IN CUTTING AND BUCKING UP SAID LOGS, AND THE NAME OF THE OWNERS OR REPUTED OWNERS OF SAID LOGS, IS HARRY DUNLAP AND HERMAN THEIL, PARTNERS, AND THAT SAID OWNERS OR REPUTED OWNERS EMPLOYED SAID CLAIMANTS TO PERFORM SAID LABOR UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

THAT SAID HARRY DUNLAP AND HERMAN THEIL, PARTNERS, AGREED TO PAY THE SAID CLAIMANTS THE SUM OF FIVE DOLLARS (\$5.00), PER DAY EACH AND EVERY DAY WORKED BY EACH OF SAID CLAIMANTS IN CUTTING AND ASSISTING IN CUTTING AND BUCKING UP SAID LOGS, AND THAT SAID CLAIMANT W. J. KELLEY WORKED A TOTAL OF SEVENTEEN DAYS, WHICH AT THE AGREED WAGE PER DAY WOULD AMOUNT TO THE SUM OF \$85.00, AND THAT SAID CLAIMANT FRED WALTHER WORKED
