NOTICE IS HEREBY GIVEN, THAT W. J. KELLEY AND FRED WALTHER, OF SKAMANIA COUNTY, STATE OF WASHINGTON, CLAIM A LIEN ON A QUANTITY OF SAW LOGS BEING ABOUT 75 THOUSAND FEET LOCATED AND NOW LYING IN THE WOODS ON THE FOLLOWING DESCRIBED TRACT OF LAND, TO-WIT:

SECTION 11, TOWNSHIP 3 NORTH, RANGE 9 E. W.M., IN SKAMANIA COUNTY, STATE OF WASHINGTON;

THAT SAID PILES WERE CUT AND REMOVED FROM THE PROPERTY OF CLAIMANT BETWEEN THE FIRST DAY OF NOVEMBER, 1925 AND THE 24TH DAY OF DECEMBER, 1925 AND THIRTY DAYS HAVE NOT ELAPSED SINCE THE LAST OF SAID PILES WERE CUT AND REMOVED.
