NOTICE IS HEREBY GIVEN, THAT IRVIN BROCK OF SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF PILING MARKED "O" NOW AT THE LANDING AT COOKS, WASHINGTON IN SAID COUNTY OF SKAMANIA, BEING ABOUT SIX THOUSAND LINEAL FEET FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN THE MANUFACTURE OF SAID PILING; THAT THE NAMES OF THE OWNERS OR REPUTED OWNERS ARE BEN C.
