LESS, IN QUANTITY WHICH WERE CUT IN SKAMANIA COUNTY, WASHINGTON, AND ARE MARKED THUS; A PART OF SAID LOGS ARE MARKED THUS "L" AND A PART OF WHICH LOGS ARE MARKED WITH TWO PARALLEL NOTCHES AND A PART OF WHICH LOGS ARE MARKED WITH BOTH OF THE TWO FOREGOING BRANDS, AND ARE NOW LYING IN THE WIND RIVER, IN SKAMANIA COUNTY, STATE OF WASHINGTON, BETWEEN BEAR CREEK AND THE MOUTH OF SAID WIND RIVER, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN OBTAINING AND SECURING SAID LOGS.
