NOTICE IS HEREBY GIVEN THAT SAMUEL LUNG OF CARSON IN THE COUNTY OF SKAMANIA, AND STATE OF WASHINGTON, CLAIMS A LINE UPON A LOT AND PARCEL OF LOGS BEING ABOUT THREE HUNDRED THOUSAND (300,000) FEET LOG SCALE MORE OR LESS, IN QUANTITY WHICH WERE CUT IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND ARE MARKED THUS (HD) WITH CONNECTED "H AND D" AND ARE NOW LYING IN THE WIND RIVER IN SAID COUNTY OF SKAMANIA BETWEEN ST. MARTIN S RINGS AND THE COLUMBIA RIVER AND A PART OF WHICH LOGS ARE NOW LYING IN THE COLUMBIA RIVER NEAR THE MOUTH OF THE SAID WIND RIVER, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN OBTAINING AND SECURING SAID LOGS. ALL PILING IS INTENDED TO BE INCLUDED WITH THE ABOVE DESCRIBED LOGS, AND AFFIANT CLAIMS A LIEN UPON A PARCEL OF PILING, BEING ABOUT FIVE THOUSAND (5000) LINEAL FEET MORE OR LESS IN QUANTITY, WHICH WERE CUT IN SAID SKAMANIA COUNTY, STATE OF WASHINGTON AND ARE MARKED THE SAME AS THE ABOVE DESCRIBED LOGS AND ARE LYING IN THE SAME LOCATION AS SAID LOGS IN THE SAID WIND RIVER AND COLUMBIA RIVER, AND UPON WHICH THIS AFFIANT CLAIMS A LIEN FOR LABOR PERFORMED AND ASSISTANCE RENDERED IN OBTAINING AND SECURING SAID PILING; THAT THE NAME OF THE OWNER OR REPUTED OWNER IS H. G. DUBOIS; THAT SAID H. G. DUBOIS EMPLOYED THIS CLAIMANT TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO WIT:

THAT THE SAID H. G. DUBOIS AGREED TO PAY THIS CLAIMANT FOR SUCH LABOR AND ASSISTANCE THE SUM OF \$1.25 PER THOUSAND FEET LOG SCALE FOR LOGS SO OBTAINED AND SECURED AND FOR PILING SO SECURED THE SUM OF ONE CENT PER LINEAL FOOT, THAT SAID CONTRACT HAS BEEN DULY AND FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF THE SAID CLAIMANT SAMUEL LUNG WHO PERFORMED LABOR UPON AND ASSISTED IN OBTAINING AND SECURING SAID LOGS AND PILING IN THE AMOUNT OF 61572 FEET OF LOGS AND 774 FEET OF PILING AND THAT SAID LABOR AND ASSISTANCE WERE SO PERFORMED AND RENDERED UPON SAID LOGS AND PILING BETWEEN THE 30 DAY OF APRIL, 1927 AND MAY 24, 1927; AND THE RENDITION OF SAID SERVICES WAS CLOSED ON THE 24TH DAY OF MAY, 1927; THAT THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF THE CLAIMANTS DEMAND FOR SAID SERVICE IS \$72.61; THAT NO PART THEREOF HAS BEEN PAID; AND THAT THERE IS NOW DUE AND REMAINING UNPAID THEREON THE SUM OF \$72.61 AFTER DEDUCTING ALL JUST CREDITS

NOTICE IS HEREBY GIVEN THAT ON THE 28TH DAY OF MARCH, 1927 AT THE REQUEST OF H. G. DUBOIS THE ABOVE NAMED CLAIMANT COMMENCED TO PERFORM LABOR IN THE OPERATION OF THE SAID BUSINESS OF SAID H. G. DUBOIS (IN THE OPERATION OF HIS BUSINESS AS A LOGGER AND TIMBER COMPANY) NEAR CARSON, SKAMANIA COUNTY, WASHINGTON, NEAR THE MOUTH OF THE LITTLE WIND RIVER, IN WHICH BUSINESS THE SAID H. G. DUBOIS WAS AND IS THE OWNER OR REPUTED OWNER: THAT THE TERMS AND CONDITIONS OF THE CLAIMANT'S CONTRACT OF EMPLOYMENT WERE AS FOLLOWS: TO WIT:

THAT SAID H. G. DUBOIS AGREED TO PAY THE SAID CLAIMANT THE SUM OF FIFTY (50) CENTS PER HOUR FOR THE LABOR SO PERFORMED. THAT CLAIMANT PERFORMED LABOR FOR 120 HOURS UNDER SAID AGREEMENT AND SO EARNED UNDER SAID CONTRACT THE SUM OF SIXTY DOLLARS. THAT NOTHING HAS BEEN PAID THEREON EXCEPT THE SUM OF \$19.20 PAID BY CREDIT FOR MEALS FURNISHED TO CLAIMANT, LEAVING A BALANCE DUE CLAIMANT IN THE SUM OF \$40.80. THAT THE SAID LAST NAMED SUM IS NOW DUE AND OWING TO THE CLAIMANT FROM SAID H. G. DUBOIS AFTER ALLOWING ALL JUST CREDITS AND OFFSETS AND DEDUCTING SAME.

THAT THE PERFORMANCE OF SUCH LABOR CEASED ON THE 14TH DAY OF APRIL, 1927.

FOR WHICH LABOR THE SAID CLAIMANT CLAIMS A LIEN ON ALL THE PROPERTY HEREIN DESCRIBED AND ON THE FRANCHISE, EARNINGS, AND ON ALL THE REAL AND PERSONAL PROPERTY OF SAID H. G. DUBOIS WHICH IS USED IN THE OPERATION OF HIS BUSINESS, OR WAS SO USED IN THE OPERATION OF HIS BUSINESS, INCLUDING ALL PROPERTY DESCRIBED IN THAT CERTAIN PRETENDED CHATTEL MORTGAGE MADE BY THE SAID H.
