NOTICE IS HEREBY GIVEN THAT C. L. WELDON OF STEVENSON, WASH., CLAIMS A LIEN UPON A QUANTITY OF LOGS, BEING ABOUT 1,168,000 FT. IN QUANTITY, WHICH WERE CUT IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND SOME OF WHICH ARE NOW LYING THE MILL POND OF RYAN & ALLEN AND SOME IN THE WOODS ON SE0 NE SEC. 26 TOWNSHIP 3, RANGE 7 E.W.M. FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN FALLING AND BUCKING SAID LOGS; THAT THE NAME OF THE OWNER OR REPUTED OWNER OF SAID LOGS IS H. L. GROAT AND J. R. KEE; THAT THEY EMPLOYED SAID C. F. WELDON TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT;

THE SAID H. L. GROAT AND J. R. KEE AGREED TO PAY THE SAID C. F. WELDON FOR SAID FALLING AND BUCKING OF SAID LOGS AT THE RATE OF \$1.00 PER THOUSAND FEET; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF THE SAID C. F.
