E. PERLE HAMILTON TO MURPHY TIMBER CO.

NOTICE IS HEREBY GIVEN THAT ON THE 11TH DAY OF JULY, 1927, AT THE REQUEST OF THE MURPHY TIMBER COMPANY, A CORPORATION, THE UNDERSIGNED E. PERLE HAMILTON, COMMENCED TO PERFORM WORK AND LABOR FOR THE SAID MURPHY TIMBER COMPANY, IN OPERATING TWO MACHINES, CALLED, INCLINE MACHINES, AND SOME CALL THEM LOWERING MACHINES, AND ONE OF SAID MACHINES WAS THEN 16 BY 20, WILLAMETTE AND THE OTHER OF SAID MACHINES WAS THEN 12 BY 14, WILLAMETTE, AND ALSO IN RUNNING A CERTAIN SHAY LOCOMOTIVE ENGINE, FOR SAID MURPHY TIMBER COMPANY, WHICH SAID MACHINES AND LOCOMOTIVE WERE THEN AND THERE USED BY THE SAID MURPHY TIMBER COMPANY AT ITS LOGGING CAMP IN SKAMANIA COUNTY, WITHIN THE STATE OF WASHINGTON, DURING ALL THE TIME OF THE EMPLOYMENT OF THE UNDERSIGNED WITH SAID MURPHY TIMBER COMPANY BETWEEN THE 11TH DAY OF JULY, 1927, AND THE 17TH DAY OF

PERLE HAMILTON, THE UNDERSIGNED CLAIMANT, COMMENCED TO PERFORM SAID WORK AND LABOR FOR THE SAID MURPHY TIMBER COMPANY ON THE 11TH DAY OF JULY, 1927, AND CONTINUED TO PERFORM SAID WORK AND LABOR AS AFORESAID IN OPERATING SAID MACHINES AND LOCOMOTIVE AT OR NEAR SAID LOGGING CAMP OF SAID MURPHY TIMBER COMPANY, CONTINUOUSLY UNTIL AND ON THE 17TH DAY OF AUGUST, 1927, IN ALL WORKING AND PERFORMING LABOR AS AFORESAID FOR SAID MURPHY TIMBER COMPANY, 390 HOURS, THAT THE SAID MURPHY TIMBER COMPANY THROUGH ITS AUTHORIZED AGENTS AND FOREMEN, ONE MR. RUSSELL, AND ONE MR. CAVANAGH PROMISED AND AGREED TO PAY TO THE UNDERSIGNED E.
