ED P. HAMILTON TO MURPHY TIMBER COMPANY

NOTICE IS HEREBY GIVEN THAT ON 11TH DAY OF JULY, 1927, AT THE REQUEST OF THE MURPHY TIMBER COMPANY, A CORPORATION, THE UNDERSIGNED ED P. HAMILTON, COMMENCED TO PERFORMING WORK AND LABOR FOR SAID MURPHY TIMBER COMPANY, IN OPERATING TWO MACHINES CALLED INCLINE MACHINES, AND SOME CALL THEM LOWERING MACHINES, ONE OF SAID MACHINES WAS 16 X 20, WILLAMETTE, AND THE OTHER OF SAID MACHINES WAS A 12 BY 14, WILLAMETTE, AND RUNNING A CERTAIN SHAY LOCOMOTIVE ENGINE, FOR SAID MURPHY TIMBER COMPANY, WHICH SAID MACHINES AND LOCOMOTIVE WERE THEN AND THERE USED BY THE SAID MURPHY TIMBER COMPANY AT ITS LOGGING CAMP IN SKAMANIA COUNTY, WITHIN THE STATE OF WASHINGTON, DURING ALL THE TIME OF THE EMPLOYMENT OF THE UNDERSIGNED WITH SAID MURPHY TIMBER COMPANY BETWEEN THE 11TH DAY OF JULY, 1927 AND THE 17TH DAY OF AUGUST, 1927, BOTH DAYS INCLUSIVE, IN OPERATING ITS LOGGING BUSINESS IN SAID SKAMANIA COUNTY, STATE OF WASHINGTON, AND HAULING MATERIALS AND SUPPLIES IN CONSTRUCTION OF A RAILROAD DURING ALL THE TIME AFORESAID, THAT THE UNDERSIGNED CONTINUED TO WORK AND PERFORM LABOR ON SAID MACHINES AND LOCOMOTIVE FOR SAID MURPHY TIMBER COMPANY, FROM THE 11TH DAY OF JULY, 1927 TO THE 17TH DAY OF AUGUST 1927 BOTH DAYS INCLUSIVE, FOR SAID MURPHY TIMBER COMPANY, IN THE CARRYING ON OF THE LOGGING BUSINESS OF SAID MURPHY TIMBER COMPANY IN HAULING SUPPLIES, MATERIALS AND IN CONSTRUCTION OF A RAILROAD AT AND NEAR ITS LOGGING CAMP IN SAID SKAMANIA COUNTY IN THE STATE OF WASHINGTON, THAT THE DATE OF THE LAST SERVICE OR WORK AND LABOR PERFORMED FOR SAID MURPHY TIMBER COMPANY, WAS ON THE 17TH DAY OF AUGUST 1927, THAT THE UNDERSIGNED ED P. HAMILTON THE CLAIMANT HEREIN, COMMENCED TO PERFORM SAID WORK AND LABOR FOR THE SAID MURPHY TIMBER COMPANY, ON THE 11TH DAY OF JULY, 1927, AND CONTINUED TO PERFORM WORK AND LABOR AS AFORESAID IN OPERATING SAID MACHINES AND LOCOMOTIVE AT THE LOGGING CAMP OF SAID MURPHY TIMBER COMPANY, CONTINUOUSLY UNTIL AND ON THE 17TH DAY OF AUGUST, 1927, IN ALL WORKING AND PERFORMING LABOR AS AFORESAID FOR SAID MURPHY TIMBER COMPANY, 398 HOURS, THAT THE SAID MURPHY TIMBER COMPANY THROUGH ITS AUTHORIZED AGENT AND FOREMAN ONE MR. RUSSELL, AND ITS FOREMAN ONE MR. CAVANAGH, PROMISED AND AGREED TO PAY TO THE UNDERSIGNED ED P. HAMILTON, THE SUM OF EIGHTY-FIVE CENT PER HOUR FOR EACH HOUR OR FRACTIONAL PART OF AN HOUR FOR SAID WORK AND LABOR AS AFORESAID, THAT THE UNDERSIGNED CLAIMANT WAS ALSO BY SAID AGREEMENT OF EMPLOYMENT WITH SAID MURPHY TIMBER COMPANY, TO RECEIVE HIS BOARD AND LODGING FROM SAID MURPHY TIMBER COMPANY, FREE OF ALL COSTS AND CHARGES TO THE UNDERSIGNED, AS A PART OF COMPENSATION FOR SAID WORK AND LABOR PERFORMED BY HIM FOR SAID MURPHY TIMBER COMPANY, IN ADDITION TO THE SAID SUM OF 85 CENT PER HOUR HEREINBEFORE SET FORTH, AND THAT AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS, THERE IS NOW DUE AND OWING TO THE UNDERSIGNED CLAIMANT THE SUM OF \$338.30 FOR SAID WORK AND LABOR PERFORMED BY THE UNDERSIGNED CLAIMANT FOR SAID MURPHY TIMBER COMPANY AS AFORESAID AND DURING THE TIMES AFORESAID, WHICH SAID SUM OF \$338.30 FOR SAID WORK AND LABOR DUE THE UNDERSIGNED CLAIMANT IS DUE AND OWING THE UNDERSIGNED FROM SAID MURPHY TIMBER COMPANY FOR SAID WORK AND LABOR AS AFORESAID THAT SAID WORK AND LABOR WAS THEN AND THERE WORTH AND OF THE VALUE OF \$338.30, THAT NONE OF SAID MONEY HAS BEEN PAID, THAT THE UNDERSIGNED CLAIMANT CLAIMS A LIEN UPON ALL SAID MACHINERY ABOVE MENTIONED AND DESCRIBED INCLUDING SAID LOCOMOTIVE, FOR SAID SUM OF MONEY, TO-WIT \$338.30 FOR SAID WORK AND LABOR, AND UP ON ALL THE PROPERTY OF SAID MURPHY TIMBER COMPANY USED BY IT IN THE OPERATING ITS SAID LOGGING BUSINESS. THAT ALL SAID WORK AND LABOR WAS PERFORMED BY THE UNDERSIGNED IN SKAMANIA COUNTY, WASHINGTON.

NOTICE IS HEREBY GIVEN THAT J. J. HINKLE OF KLICKITAT COUNTY, STATE OF WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF SAWED FIR LUMBER IN THE APPROXIMATE AMOUNT OF ONE HUNDRED TWELVE THOUSAND (112,000) FEET, NOW PILED IN THE YARDS OF THE SAWMILL KNOWN AS THE HUSUM LUMBER COMPANY SAWMILL AND WHICH WAS FORMERLY THE RED FIR LUMBER COMPANY SAWMILL, LOCATED ON TAX LOT NO. 2, IN SECTION 13, TOWNSHIP 5, N. R. 10 E. W.
