NOTICE IS HEREBY GIVEN THAT J. J. HINKLE OF KLIKITAT COUNTY, STATE OF WASHINGTON,
CLAIMS A LIEN UPON A QUANTITY OF SAWED FIR LUMBER IN THE APPROXIMATE AMOUNT OF ONE HUNDRED
TWELVE THOUSAND (112,000) FEET, NOW PILED IN THE YARDS OF THE SAWMILL KNOWN AS THE HUSUM
LUMBER COMPANY SAWMILL AND WHICH WAS FORMERLY THE RED FIR LUMBER COMPANY SAWMILL, LOCATED
ON TAX LOT No. 2, IN SECTION 13, TOWNSHIP 5, N. R. 10 E. W. M., KLIKITAT COUNTY, STATE OF
WASHINGTON NEAR THE WHITE SALMON-TROUT LAKE ROAD AND ALSO A QUANTITY OF SAWED FIR LUMBER
IN THE APPROXIMATE AMOUNT OF SEVENTY THOUSAND (70,000) FEET NOW PILED UPON THE RIGHT-OF-
WAY OF THE SPOKANE, PORTLAND AND SEATTLE RAILWAY, IN THE TOWN OF UNDERWOOD, SKAMANIA COUNTY,

THAT SAID CLAIMANT J. J. HINKLE BEGAN WORKING UPON SAID LUMBER DURING THE MONTH OF MAY
ON OR ABOUT THE 9TH DAY OF SAID MONTH, 1927, IN LOGGING. THAT IS, BY HAULING THE LOGS FROM
THE TIMBER TO SAID SAWMILL AND ALSO IN HAULING THE LUMBER FROM SAID SAWMILL TO THE RIGHTS
OF-WAY OF THE SPOKANE, PORTLAND AND SEATTLE RAILWAY AT UNDERWOOD, WASHINGTON AND THAT SAID CLAIM
ANT CEASED PERFORMING ANY WORK OR LABOR UPON SAID LUMBER UPON THE 13TH DAY OF SEPTEMBER, 1927;
SAID LOGS AND SAID LUMBER BEING OUT AND MANUFACTURED IN KLIKITAT COUNTY, STATE OF WASHINGTON.

THAT THE NAME OF THE OWNERS OR REPUTED OWNERS OF SAID LUMBER ARE WILLIAM PELKEY
AND AL BECKMAN, DOING BUSINESS UNDER THE FIRM NAME OF HUSUM LUMBER COMPANY AND THAT SAID
NAMED PERSONS SO EMPLOYED TH, SAID CLAIMANT TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE
UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

THAT SAID WILLIAM PELKEY AND AL BECKMAN, PARTNERS, DOING BUSINESS UNDER THE FIRM NAME
OF HUSUM LUMBER COMPANY AGREED TO PAY THE SAID J. J. HINKLE, CLAIMANT, FOR SUCH LABOR AND

ASSISTANCE THE SUM OF SEVEN DOLLARS AND SEVENTY-FIVE CENTS (7.75) PER THOUSAND FEET, FOR LOGGING, HAULING AND LOADING OF SAID LUMBER AND THE SAID CLAIMANT HAS FAITHFULLY PERFORMED AND COMPLIED WITH THE TERMS AND CONDITIONS OF SAID AGREEMENT FOR TOTAL AMOUNT OF SIX HUNDRED TWENTY-SIX THOUSAND FEET (626,000) OF LOGS AND LUMBER AND THAT THE RENDITION OF SAID SERVICES WAS CLOSED ON THE 13TH DAY OF SEPTEMBER, 1927.

THAT THIRTY (30) DAYS HAVE NOT ELAPSED SINCE SAID TIME AND THAT THE AMOUNT OF CLAIMANT'S DEMAND FOR SAID SERVICES IS THE SUM OF FOUR THOUSAND THREE HUNDRED SEVENTY-NINE DOLLARS, (\$4,379.00) AND THAT NO PART THEREOF HAS BEEN PAID EXCEPT THREE THOUSAND THREE HUNDRED FORTY DOLLARS AND TWENTY-SEVEN CENTS (\$3,340.27) AND THAT THERE IS NOW DUE AND REMAINING UNPAID THEREON AFTER DEDUCTING ALL JUST CREDITS AND OFF SETS THE SUM OF ONE THOUSAND THIRTY-EIGHT DOLLARS AND FIFTY-THREE CENTS (\$1,038.53), IN WHICH AMOUNT SAID CLAIMANT CLAIMS A LIEN UPON SAID LUMBER AND SAID CLAIMANT CLAIMS A LIEN UPON ALL SAID SAWED FIR LUMBER NOW OWNED BY SAID WM.
