

ASSISTANCE THE SUM OF SEVEN DOLLARS AND SEVENTY-FIVE CENTS (7.75) PER THOUSAND FEET, FOR LOGGING, HAULING AND LOADING OF SAID LUMBER AND THE SAID CLAIMANT HAS FAITHFULLY PERFORMED AND COMPLIED WITH THE TERMS AND CONDITIONS OF SAID AGREEMENT FOR TOTAL AMOUNT OF SIX HUNDRED TWENTY-SIX THOUSAND FEET (626,000) OF LOGS AND LUMBER AND THAT THE RENDITION OF SAID SERVICES WAS CLOSED ON THE 13TH DAY OF SEPTEMBER, 1927.

PELKEY AND AL BECKMAN, PARTNERS, DOING BUSINESS UNDER THE FIRM NAME OF HUSUM LUMBER COMPANY OF SAID COUNTY OF KLICKITAT, TO SECURE PAYMENT FOR THE WORK AND LABOR PERFORMED IN OBTAINING OR SECURING AND HAULING THE SAID LOGS, SPARS, FILES OR OTHER TIMBER, LUMBER OR SHINGLES HEREIN DESCRIBED.

NOTICE IS HEREBY GIVEN, That John Good of Klickitat County, State of Washington, claims a lien upon a quantity of sawed fir lumber in the approximate amount of one hundred thousand (100,000) feet, now piled upon the right-of-way of the Spokane, Portland and Seattle Railway, in the town of Underwood, Skamania County, State of Washington.

That said claimant John Good began work upon said lumber on or about the 14th day of September, 1927, in hauling said lumber from the sawmill of the Husum Lumber Company located near Husum, in Klickitat County, State of Washington, to the Spokane, Portland

and Seattle Railway right-of-way at Underwood, in Skamania County, State of Washington, and that said claimant ceased performing any work and labor on said lumber on the 21st day of October, 1927, said lumber being cut and manufactured in Klickitat County, State of Washington.

That the name of the owners or reputed owners of said lumber are William Pelkey and Al. Beckman, doing business under the firm name of Husum Lumber Company, and that said named persons so employed this said claimant to perform such labor, and render such assistance upon the following terms and conditions, to-wit:

That said William Pelkey and Al. Beckman, partners, doing business under the firm name of Husum Lumber Company agreed to pay the said John Good, Claimant, for such labor and assistance the sum of \$3.00 per thousand for all lumber hauled by said Claimant from the said sawmill of the Husum Lumber Company to the Spokane, Portland and Seattle Railway at Underwood, Washington, and \$3.50 per thousand for lumber hauled from said sawmill of the Husum Lumber Company to Hood, Washington, and that said Claimant has faithfully performed and complied with the terms and conditions of said agreement, and has hauled a total amount of lumber from the sawmill of the said Husum Lumber Company to the Spokane, Portland & Seattle Railway right-of-way at Underwood, Washington, of 355,705 feet, and hauled from the sawmill of said Husum Lumber Company to Hood, Washington, a total of 3,891 feet.

That thirty (30) days have not elapsed since said time, and that the amount of claimant's demand for said services is the sum of One Thousand Ninety-three Dollars and Ninety-five Cents (\$1093.95), and that no part thereof has been paid except the sum of Four Hundred Seventy-eight Dollars and Forty Cents (\$478.40), and that there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of Six Hundred Fifteen Dollars and Thirty cents (\$615.30), in which amount said claimant claims a Lien upon said lumber and said claimant claims a Lien upon all of said sawed fir lumber now owned by said William Pelkey and Al. Beckman, partners doing business under the firm name of the Husum Lumber Company of said county of Klickitat, State of Washington, located as above described, to secure payment for the work and labor performed by the said claimant in obtaining, or securing and hauling the said logs, spars, piles, or other timber, lumber or shingles herein described.
