NOTICE OF LIEN

Notice is hereby given that A. W. Anderson of Skamania County, State of Washington, claims a lien upon certain logs marked "H" & G the Carney Logging Company brand, and also branded "35" by A. W. Anderson, being about 150,000 feet in quantity, which were cut in Skamania County, State of Washington, and are now lying about 75,000 feet, marked "H" on the beach just east of Cooks and in the lakes just east of Cooks, Skamania County, Washington, and about 75,000 feet, marked "G" in the Columbia River, being towed to Vancouver, Washington, for labor performed upon and assistance rendered in hauling said logs; that the name of the owner, or reputed owner, of said logs is T. O. Carney and D. H. McCall, co-partners doing business as the Carney Logging Company; that said T. O. Carney and D. H. McCall, co-partners doing business as the Carney Logging Company, employed said claimant to perform such labor and render such assistance upon an expressed agreement to haul said logs at the rate of Three Dollars (\$3.00) per thousand and to work on the rollway of said logs for the sum of Two Dollars (\$2.00) per hour; that said T. O. Carney and D. H. McCall, co-partners doing business as the Carney Logging Company, agreed to pay said claimant for such labor and assistance the sum of Three Dollars (\$3.00) per thousand for hauling said logs and the sum of Two Dollars (\$2.00) per hour for working on said rollway; that said contract has been faithfully performed and fully

complied with on the part of said claimant, who hauled 320,181 feet of said logs and performed 4½ hours work on said rollway for the period between the 25th day of June, 1928, and the 9th day of September, 1928; that the rendition of said work and labor was closed on the 8th day of September, 1928, and thirty days have not elapsed since that time; that the amount of claimant's demand for said services is the sum of \$969.54; that no part thereof has been paid except the sum of \$623.18, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$376.36, and for which amount claimant claims a lien upon said logs; that said claimant also claims a lien on all logs and lumber now owned by said T. O. Carney and D. H. McCall, co-partners doing business as Carney Logging Company, of said Skamania County, State of Washington, to secure payment for the work and labor performed, and obtaining or securing said logs or lumber.
