


NOTICE OF LIEN CLAIM

T. O. Carney and D. H. McCall

Notice is hereby given that Sarah McCall, of Hoquiam, Wash. claim a lien upon a

quantity of sawlogs being about 110 M all of which were cut and manufactured in Skamania county Washington, there being about 85 M of said logs in a "Brail" or raft in the Little white Salmon River, near Cooks, Skamania County, Wash. marked "H" and about 15 M of said logs in a boom in the Columbia river near Cooks, Washington, marked ; also upon a brail or raft of logs containing about 85 M now in the Columbia River at Vancouver Washington, and marked ; which said logs were also cut and manufactured in Skamania County, Washington; that said lien is claimed for work and assistance rendered in the manufacture of said sawlogs by claimant; that the owner, or reputed owner of said logs is the Carney Logging Company, a co-partnership composed of T. O. Carney and D. H. McCall, who employed claimant to perform such labor and work and render such assistance upon the following terms, to-wit;

That the said owners employed claimant as cook at their logging camp in Skamania County, Washington, at the place where said logs were cut and manufactured, upon an agreed wage or salary of \$150.00 per month; that the said contract has been faithfully performed and fully complied with on the part of said claimant who performed said labor and rendered such assistance in and for the manufacturing of said sawlogs for a period of four months and 27 days; that said labor and assistance were so performed and rendered upon said sawlogs between the 14th day of April 1928 and the 13th day of September 1928 and the rendering of said service was closed on the 12th day of September 1928 and 30 days have not elapsed since that time; that the amount of claimant's demand for such service is the sum of \$729.74 and that no part thereof has been paid except the sum of \$143.24 and there is now remaining due and unpaid thereon the sum of \$586.24 after deducting all just credits and offsets, in which sum she claims a lien upon said sawlogs.

The said Sarah McCall also claims a lien upon all said sawlogs owned by Carney Logging Company of said county to secure payment for the work and labor performed in obtaining or securing the said logs herein described.

The said Sarah McCall also claims a lien for the work, labor and assistance performed and rendered as above setout, in the said sum of \$586.24 upon all franchises, earnings, and on all real and personal property of said company which is used in the operation of its business, and in particular the following, to-wit:

2 Mallory High Lead Blocks; 30 x 5; 1 Lamb block 30 x 5; 1 Lang range;
all cooking utensels, dishes; 20 iron bunks; 20 mattresses; 24 blankets;
1 Ford Truck.

NOTICE IS HEREBY GIVEN That GEORGE C. HOWARD of Multnomah County, Oregon, claims a lien upon a certain lot of saw logs, being about 250,000 feet, b.m., in quantity, one brail of which is located at a point on the Columbia River known as Ryan Point, in Clark County, Washington, one brail in located at the mouth of Drano Lake near Cooks, in Skamania County, Washington, the balance being inside the boom near Cooks, Washington, in the open Columbia River known as the Snodgrass boom. That the logs are marked variously with the following brands: "G" "H" "31" or "35".

That the name of the owners or reputed owners of the same are D. H. McCall, T. O. Carney, or the Carney Logging Co. defendants above named.

That the claimant George C. Howard claims a lien upon 250,000 feet for stumpage, the same being the agreed purchase price which the defendants above named agreed to pay to this claimant, amounting to \$600.00, as stumpage for said logs, which claimant permitted the defendants to cut from the following described real property, to-wit:

The East Half of the North East Quarter (E $\frac{1}{2}$ NE $\frac{1}{4}$)
of Section 21, Township 3 North, Range 9 East W. M.,
Skamania County, Washington.

That the defendants above named ceased to cut logs upon the premises above described within less than thirty (30) days from the date of this lien notice.

That there is a total sum now due and owing to this claimant for said stumpage upon the timber so cut of \$600.00 over and above all just credits and off-sets, for which amount this claimant now claims a lien on the logs above described.
