Witnesseth that the party of the first part for and in consideration of the sum of Two Thousand three hundred Dollars paid to me by the party of the second part the receipt whereof is hereby acknowledged have bargained, sold and conveyed and by these presents do bargain, sell and Convey unto the party of the second part the following described parcel or tract of land lying and being in Skamania County Territory of Washington To Watt:

The North west quarter of the North east quarter and Lot one of section four and lot two of section three township one North Range six east. South west quarter of the South west section thirty four (34) Township two North range six east of the Willamette Meridian containing one hundred and fifty five acres more or less.
