That the said Louis Pearson agreed to pay the said claimant for such labor and x assistance \$ 6.00 per day, less b and of \$1.20 per day, leaving a net wage of \$4.80 per/due claimant; that said contract has been fatthfully performed and fully complied with on the part of said cleimant, who performed labor supon and assisted in procuring said logs, piling, polies and worked upon and about said machinery and equipment and commissary building for the period of 14 days; that said labor and assistance were so performed and rendered between the 11th day of Feb.,1929 and the 27th day of Feb.,1929; that the rendition of said services were closed on the 26th day of Feb, 1929 and thirty days have not elapsed since that time; that the amount of the claimants demand for said services is \$63.80 and there is now due and remaining unlaid thereon, after deducting all just credits and offsets the said sum of \$63.80, in which amount he claims a lien upon said logs, piling, poles, donkey engine, lines, equipment, commistary building; the said claimant also claims a lien on all said logs, piles, poles, donkey engine, lines, equipment tools, buildings now owned by said Loius Pearson or his assochates or in which he or they have or may have an interestnto secure payment for the work and labor performed in obtaining and securing said logs, piling, poles, and work in connection with said donkey engine, lines, equipment buildings etc.
