To have and to hold the above granted and described premises unto them the said Peter C. McFarlane, W. B. Wells and Charles L. Gray and unto their heirs and assigns forever. To all to whom these presents shall come, Greeting
Whereas, there has been deposited in the
General Land Office of the United States a
Certificate of the Register of the Land Office at
Vancouver Washington Territory whereby it appears
that pursuant to an "Act of Congress approved
May 20. 1862 "To secure Homesteads to actual
Settlers on the Public Domain" and the acts
supplemental thereto, the claim of Carl Busch-
lach, has been established and duly consum-
mated, in Conformity to law, for the West half
of the South West Quarter, the South East quarter
of the South West Quarter, and the South West
Quarter of the North West Quarter of Section four
in Township one North of Range five East of
Willamette Meridian, in Washington Territory, Contain-
ing One hundred and sixty acres, according to the
Official Plat of the Survey of the said Land, re-
urned to the General Land Office, by the Surveyor
General: -

Now Know Ye, That there is, therefore granted by
the United States unto the said Carl Buslach, the
tract of land above described: To have and to
hold the said tract of land, with the appurte-
nances thereof, unto the said Carl Buslach, and
to his heirs and assigns forever; subject to any
existing and accrued water rights for mining,
agricultural, manufacturing, or other purposes,
and rights to ditches and reservoirs used in Con-
nection with such water rights, as may be recog-
nized and acknowledged by the local customs,
laws and decisions of courts, and also subject
to the right of the proprietor of a vein or lode
to extract and remove his ore therefrom, should
the same be found to penetrate, or intersect the premises
hereby granted as provided by law.
