NOTICE IS HEREBY GIVEN that the undersigned, ARNOLD JETFRIES, of Skamania County, State of Washington, Claims a Lien upon Six Brails of Fir saw logs, being about 300,000 feet, board measure in quantity which were cut, secured or manufactured in Skamania County, State of Washington, and are now lying in the Columbia River, as follows:

In the Columbia River near the North Bank thereofabout 12 miles East of the Inter State Bridge at Vancouver, Washington, along the North Bank of said river and adjointry the real estate owned by Hidden Brothers, formerly known as the Ryan D. L. C., and the other three (3) brails, containing about 150,000 feet board measure, of said logs, are situated and are now lying in the said Columbia R iver, near the north bank thereof, and adjoining the real property now owned by the Sisters of Charity of the House of Providence, and blow the saw mill owned and operated by Dubois-Matlack Lumber Company, below or down stream from the Spokare, Portland and Seattle Rail Way Bridge, and below the westerly limits of the City of Valcouver, Washington. Which said claim is for labor performed upon and rendered in Cutting, obtaining and securing said logs and in building roads over which said logs were hauled and transported from the place they were cut in Skamar. County, Washington.

That the name of the owner, or reputed owner of said logs is F. M. Fowler, doing business as Fowler Logging Company, and that the said Fowler Logging Company has, or claims to have some interest in said logs.

That the said F. M. Fowler and the Fowler Logging Company employed the claimant, the said Arnole Jeffries to perform said labor and render such assistance upon the following terms and conditions, to-wit;

The said F. M. Fowler and the said Fowler Logging Company promised and agreed to pay claimant, the said Arnold Jeffries, for such work, labor, services and assistance rendered, the sum of \$5.00 per day of Eight (8) hours, for each days, work or labor furnished and performed by claimant.

That pursuant to said agreement, claimant commenced to work and labor for said F. M. Fowler and Fowler Logging Company in getting out and cutting said logs, on the 14th day of February, 1930, and continued to so work and furnish labor and assistance in the cutting, securing and removing said logs and in building roads over which said logs were to be transported from the place where they were cut down to and including the 3rd day of July, 1930.

That the said contract has been faithfully performed and fully complied with on the part of this claimant, who performed labor and rendered services and assisted in cutting and securing said logs and in building a private road in Skamania County, Washington, over which said logs were hauled, for the period of 98 3/4 days, commencing February 14, 1930 and ending on the 3rd day of July, 1930, both days inclusive, and that by reason thereof the said F. M. Fowler and Fowler Logging Company became indebted to Claimant in the full sum of \$493.75

That the rendition of said labor and the rendering of such assistance remered in the satting and securing of said logs and in building said roads ceased on the evening of July 3rd, 1930.

That Thirty (30) days have not elapsed since the day claimant deased to perform labor and render assistance in cutting and securing said logs as above specified.

That the amount of Claimants demand for said labor and services \$493.75:

That no part thereof has been paid, and that there is now justly due and remaining unpaid thereof the Juli sum of \$493.75, after deducting all just debts and offsets, the full sum of \$493.75, for which sum and amount the the claimant, the said Arnold Jeffries, claims a Lien upon the said logs to secure payment for the work, labor and assistance rendered and performed in cutting, obtaining and securing saig logs as herein above described.
