

16850- Claim of Lien

Notice is hereby given that W.M.Obrist, of Grays Harbor County, State of Washington, claims a lien upon a brail of raft of saw logs, being about 64,630 board feet in quantity, which were cut or manufactured in Skamania County, State of Washington, are marked thus "FF", and are now lying in the Columbia River at the mouth of the Little White Salmon River in Skamania County, State of Washington, for labor performed upon and assistance rendered in obtaining and securing and yarding and loading said saw logs in said Skamania County, State of Washington; that the name of the owner or reputed owner of said saw logs is F.M.Fowler and Mrs. F.M.Fowler, husband and wife; that said F.M.Fowler and Mrs. F.M.Fowler employed and agreed to pay J.R. Grigg and W.L.Armstrong, who were then and there the agents of said F.M.Fowler and Mrs. F.M.Fowler, to obtain and secure and yard and load said saw logs and that the said J.R. Grigg and W.L.Armstrong employed said W.M.Obrist to perform such labor and render such assistance upon the following terms and conditions, to-wit: that the said J.R. Grigg and W.L.Armstrong would pay the said W.M.Obrist the sum of Eight dollars per day for each and every day such labor and assistance was performed.

That said J.R. Grigg and W.L.Armstrong agreed to pay the said W.M.Obrist for such labor and assistance in obtaining and securing and yarding and loading said logs; that said contract has been faithfully performed and fully complied with on the part of W.M.Obrist, who performed labor upon and assisted in yarding and loading said saw logs for the period of twenty-six and one half days; that said labor and assistance were so performed and rendered upon said saw logs between the 1st day of September, 1930, and the 5th day of October, 1930 and the rendition of said services was closed on the 5th day of October, 1930, and thirty days have not elapsed since that time; that the amount of claimants demand for said services is \$220.00; that no party thereof has been paid except the sum of \$119.60 and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$100.40, in which amount he claims a lien upon said saw logs; the said W.M.Obrist also claims a lien on all said logs now owned by said F.M.Fowler of said county to secure the payment for such work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
