Notice is hereby given that C. L. Weldon of Skamania County, Washington, claims a lien upon a quantity of saw logs being about 2,000,000 feet in quantity which were cut or manufactured in Skamania County, State of Washington. That said logs bear no identification mark. Approximately 1,800,000 feet of the said saw logs are lying on the ground in the woods and on roll ways at the site of the logging operation of the above named owners all in section 10, township 2 north range 7 east of W. M. and about

240,000 feet thereof are in brailles and rafted and in the Columbia River at Hamilton Island approximately three miles down stream from the Cascades of the Columbia River, there being three brailles of said logs composing the above mentioned raft.

That said claim is for labor performed upon and assistance rendered in falling and bucking the said saw logs; that the names of owners or reputed owners are Robert Barr and Ed Ersted.

That the claimant was employed to perform said services and rendered the same upon the following terms and conditions, to-wit:

That the said owners employed one Robert McDonald as their agent, servant and contractor to fall and buck the timber owned by them and standing and being upon the above Section 10, T. 2 N. R. 7 E. W. M. for the sum of 50¢ per thousand feet log measure. That the said Robert McDonald employed claimant and one Roy Smith to assist in said work, each of said workers to receive the sum of 16 2/3¢ per thousand feet, That said arrangement continued from the 10th day of November, 1933, to the 27th day of February, 1934, during which period a total of 1,800,000 feet of logs were cut for which claimant was entitled to receive the sum of \$300.00; that subsequent to the said 27th day of February, 1934, the said Robert McDonald and claimant cut a total of 400,000 feet of logs for which claimant was to receive the sum of 25¢ per thousand feet or a total of \$100.00.

That the said contract was faithfully performed and fully complied with on the part of claimant who performed labor upon and assisted in falling and bucking the said logs during the period commencing on the 10th day of November, 1933, and ending on the 13th day of April, 1934, and said service were closed on the said 13th day of April, 1934, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service and the reasonable value thereof is \$400.00 and no part thereof has been paid except the sum of \$154.60, and there is now due and remaining unpaid thereof after deducting all just credits and off-sets the sum of \$245.40 in which amount he claims a lien upon said saw logs.

That claimant also claims a lien upon all saw logs now owned by the above named owners in Skamania County, Washington, for labor performed as aforesaid.
