Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and also all my estate, right, title, and interest in and to the same including dower and claim of dower.

To Have and To Hold the above described and granted premises unto the said Peder Martin Pederson his heirs and assigns forever. And I, Frederick Zahl, grantor above named do covenant to and with Peder Martin Pederson, the above named grantee, his heirs and assigns, that the above named grantee, his heirs and assigns, shall and lawfully shall enjoy the above granted premises and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
