The North East quarter, and lots one (1) two (2) three (3) and four (4) of Section four (4) and lot two (2) of Section three (3) in Township one (1) North of Range Six (6) East of the Willamette Meridian, containing in the aggregate 388 & 25/100 acres of land, situated in Skamania County State of Washington: Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining: To Have and To Hold the above granted and described premises unto him the said Thomas N. Strong, and unto his heirs and assigns forever.
