TO HAVE AND TO HOLD the above granted premises unto him the said Frank Marble and unto his heirs and assigns forever.

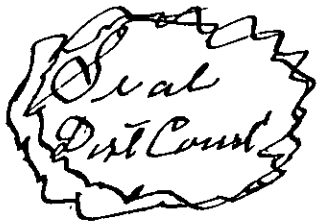
