THE UNITED STATES OF AMERICA: To all to whom these presents shall come, Greeting:-
 WHEREAS, Mary A. Allan of Pierce County Washington Territory, has ~~been~~ deposited in the Gen-
 eral Land Office of the United States a Certificate of the Register of the Land office
 at Vancouver, Washington, Territory, whereby it appears that full payment has been made by
 the said Mary A. Allan, according to the provisions of the act of Congress of the 24th of
 April, 1820, entitled "An ACT making further provision for the sale of the Public Lands"
 and the acts supplemental thereto, for the North West quarter of Section Twenty in Town-
 ship three North of Range Six East of Willamette Meridian in Washington Territory, contain-
 ing one hundred and Sixty acres according to the official Plat of the Survey of the said
 Lands, returned to the General Land Office by the Surveyor General, which said Tract has
 been purchased by the said Mary A. Allan. Know Now Ye. That the United States of America, in
 consideration of the premises and in conformity with the several Acts of Congress in such
 case made and provided have given and granted and by these presents do give and grant, unto
 the said Mary A. Allan and to her heirs ~~and assigns~~ the said Tract above described: To Have
 and To Hold the same, together with all the rights, privileges, immunities, and appurtenances,
 of whatsoever nature thereunto belonging, unto the said Mary A. Allan and to her heirs and
 assigns forever, subject to any vested and accrued water rights, for mining, agricultural,
 manufacturing or other purposes and rights to ditches and reservoirs used in connection
 with such water rights, as may be recognized and acknowledged by the local customs, laws and
 decisions of Courts, and also subject to the right of the proprietor of a vein or lode to
 extract and remove his ore therefrom, should the same be found to penetrate or intersect
 the premises hereby granted, provided by Law...
