 to prosecute and defend, at his cost, any litigation respecting them, or any contract relating thereto, or any trespass thereon or any injury thereto, to sell and confirm the same, in whole or in part, on such terms and for such consideration as he shall think fair: to receive the consideration of such sales and confirmations, and grant acknowledgements, therefor: To make and deliver any instruments, sealed or not, with power and right of substitution association, and revocation; hereby agreeing that I will at any time, execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered such further assurance of title to said property as said Attorney, associates, substitutes or assigns, may reasonably require: and hereby granting to said attorney, associates and substitutes, power to sign my name with words of procuration, in all cases, and to do all things convenient and proper for enforcing this instrument as fully as I could and should do if present and acting in person: and hereby ratifying all such things when done, and revoking any authority which I may, by possibility, have heretofore granted, in conflict with this power.

In consideration of One hundred and Fifty Dollars, paid by said Attorney, the receipt whereof is hereby acknowledged, (and which is to be refunded with legal interest in case any irrevokable power of attorney, conflicting herewith, has been heretofore made by the undersigned,) this power is hereby made irrevokable, to the exclusion of the undersigned and all others not authorized by said Attorney, who is hereby released from all claim or obligation for any of the proceeds or price of said Additional homestead and appurtenances: and I allege that I have never made any irrevokable power conflicting herewith. 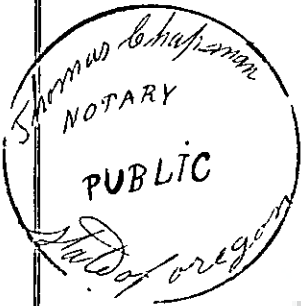
