To all to whom these presents shall come, Greeting:

Whereas, There has been deposited in the General Land Office of the United States, a Certificate of the Register of the Land Office at Vancouver Washington, Territory, whereby it appears that pursuant to an act of Congress approved 20th May, 1862, "To secure Homesteads to actual settlers on the Public domain", abd the acts supplemental thereto, the claim of William Graves has been established, and duly consumated, in conformity to law of the North Half of the South East quarter of Section twelve (12) in Township Two North of Range Five East of Willamette Meridian, in Washington Territory, containing eighty acres, according to the official Plat of the Survey of saidlands returned to the General Land Office by the Surveyor General:

Now Know Ye, that there is therefore, granted by the UnitedStates unto the said William Graves, the said tract of land, with the appurtenances thereof, unto the said William Graves and to his heirs assigns forever; subject to any evested and accrued water rights for mining agricultural, manufactruing or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognised and acknowledged by the local customs, laws, and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law.

In Testimony Whereof I Chester A.Arthur President of the United States of America have caused these letters to be made Patent and the Seal of the General Land Office to be hereunto affixed.
