Know all Men by these Presents, That I, Rozella Clark residing in the County of Multnomah and State of Oregon have made, constituted and appointed, and by these presents do make, constitute and appoint Dell Stuart of Portland, County of Multnomah in the State of Oregon, My True And Lawful Attorney, for me and in my name place and stead, to collect, receipt for and receive, all claims and demands due, or that may become due to me, including judgments, Accounts and all other rights, claims and demands, and he is authorized to settle, compromise, compound or discount any and all such demands, if his judgment shall so direct him. Also to foreclose any mortgage, chattel mortgage, or other lien existing, or that may exist in my favor. Also to resell the large "Frankie" heretofore sold or contracted by me to A. D. Morgan, if said barge shall come back to my ownership. Also to sell and dispose of any wood or Rail Road ties which may now or hereafter belong to me in Oregon or Washington, at such price and on such terms as he may deem best. Also to take charge of my Lease rights in a certain tract of woodland in Skamania County Washington, and to authorize the taking of wood and timber products therefrom on such terms as may to him seem best. Also to authorize others to act for me in all of the business coming into the hands of my said attorney in fact, on such terms and for such compensation as he may deem right. And I especially commend to him Mr. R. R. Coleman, as a reliable and competent person for such employment.

Giving and Granting unto my said attorney, full power and authority to do and perform all and every act and thing, whatsoever, requisite and necessary to be done, in and about the premises, as fully to all intents and purposes, as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney, or his substitute, shall lawfully do, or cause to be done, by virtue thereof.
