Tucker, according to the provisions of the Act of Congress of the 24th of April, 1820, entitled "An Act making further provisions for the sale of the Public Lands" and the acts supplemental thereto for the South Bast quarter of the North East quarter and the North East quarter of the South Eastquarter, of Section Twenty, in Township Three North of Range Eight East of Willamette Meridian in Washington Territory, Containing eighty acres, according to the official Plat of the Survey of said Lands returned to the General Land Office by the Surveyor General, which said tract has been purchased by the said Albert G. Tucker.

Now Know Ye, That the United States of America, in consideration of the premises, and in conformity with the several Acts of Vongress in such case made and provided, have Page 387 given and granted, and by these presents do give and grant, unto the said Albert G. Tucker, and to his heirs, the said Tract above described: To have and to hold the same together with all the rights, privileges, immunities and appurtenances of whatsoever nature there? unto belonging, unto the said Albert G. Tucker and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the Locall customs, laws, and decisions of Courts, . and also subject to the right of the proprietor of a vein or lode, to extract and removed his ore therefrom, should the same be found to penetrate or intersect the premises hereby ham. granted as provided by law.
