THE WNITED STATES TO KATHARINE H.KING.

The United States of America. To all to whom these presents shall come, Greeting:

Whereas Katharine H.King of Pierce County Washington Territory has been deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at VancouverdWashington Territory, whereby it appears that full payment has been made by the said Katharine H.King, according to the provisions of the Act of Congress of the 24th of April, 1820, entitled "An Act making further provision for the sale of the Public Lands" and the acts supplemental thereto, for the North East quarter of Section eight in Township two North of Range Six East of Willamette Meridian, in Washington Territory, containing one hundred and sixty acres, according to the official Plat of the Survey of the said Lands, returned to the General Land Office by the Surveyor Genegal, which said Tract hasbeen purchased by the said Katharine H.King.

Now Know Ye, That the United States of America, in consideration of the premises and in conformity with the several Acts of Congress in such case made and provided have givenand granted, and by these presents do give and grant, unto the said Katharine H. King and to her heirs and assigns forever; subject to any vested and actrued water rights for mining agricultural, manufacturing, or other purposes and the rights to ditches and reservoirs used in connection with such water rights as may be recognized and acknowledged by the customs, laws, and decisions of Courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or interest the premises hereby granted as provided by law.
