W.M. Robinson and D.B. Robinson, acting as co-partners, claimants vs. H.A. Dent. Notice is hereby given that W.M. Robinson and D. B. Robinson acting as co-partners, the former, and latter, both of Mason County, State of Washington, Claim a lien upon a quantity of logs, being about One Millian Forty Nine Thousand and Four hundred and Nine-ty feet (1,049,490) feet in quantity, which were cut or manufactured in Skamania County, State of Washington; are marked and branded "hD", more specifically the brand was and is a circle with an HD inside of the circle; approximately 400,000 feet of said logs are lying in the woods where cut, and approximately 600,000 feet in quantity are rafted in the Columbia River, that the logation of the logs is more particularily described as follows:

The logs in the woods, are located in the logging operations at the end of the old Barr Logging Company Road, which said road intersects the Evergreen Highway at Beacon Rock; the logging operations mentioned are the only logging operations in the vicinity; and the logs can be located by taking the Evergreen Highway out of Stevenson, in Skomania County, Washington, and travelling West on so a Evergreen Highway to Beacon Rock, and then at that point, turning right up the Old Bar\_ Logging Company Road and following that road to its end, the said logging road being about four and one half miles in length at the end of this said logging road begin the logging operations herein mentioned, wherein the said approximately 400,000 feet in quantity of logs are locate; the logs in the Columbia River are located in the Columbia River at a point approximately 300 yards south of the Evergreen Highway and approximately one mile and a half west of Beacon Rock on the Evergreen Highway, at a log dump located at said point, said log dump being the only one in that vicinity; said logs all being rafted together, and being green timber, and all branded with an HD in a circle.

Dent contracted the logging of said logs out to Aarts Bros., and said Aarts Bros., employed said above named claimants to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said W.M. Robinson and D.B. Robinson were to do the falling and bucking, and had the contract in writing to do all or the falling and bucking for the operation, or hire it done and oversee it: that said Aarts Bros. agreed to pay the said claimants named the sum of \$1.25 per thousand feet for all the falling and bucking done; and for their labor and assistance on the logs; that said contract has been faithfully performed and fully complied with on the part of the claimants, who performed labor upon and assisted in said falling and bucking and working up the logs and other work in to logging operation more specifically described hereinafter; that said labor and assistance were so performed and rendered upon said logs between the 28th day of August 1935 and November 22, 1935 and that the rendition of said service was closed on the 22nd day of November 1935 and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$509.57; That the claimants were also employed by the said Aarts Bros. at day labor and assistance in the logging operation for 14 days at \$4.00 per day and 13 days at \$5.00 per day during the period of time aforesaid and as wor, aside from their regular contract, and the amount of claimant's demand for said services is \$116.00; the total of claiment's demans being \$625.57; that no part thereof has been paid except the sum of \$175.00 in cash and \$135.65 in services making a total of \$308.65, and there is ow due and remaining unpaid thereon, after deducting all just credits and offsets the sum of \$316.92, in which amount they claim a lien upon said logs. The said chaimants also claim a lien on all said logs now owned by said H.D. Dent of said county, to secure payment for the work and labor performed in obtaining or securing the said logs, spare, liles or other timber, limber or shingles herein described.
