M., and running thence North 79 degrees 51' West along said highway, 50 feet; thence South 10 degrees 02' West, 100 feet; thence South 79 degrees 51' East, 51.3 feet and thence North 9 degrees 34' 30" East 100 feet to the place of beginning, said tract being designated as Lot 9, Block 4 of the unrecorded plat of the Town of North Bonneville, Skamania County, State of Washington,
