Marian S. Henderson ^{Wife} to George P. Growell.

I know all well by these Presents, That We Marian S. Henderson and John Eland Henderson, Wife and husband of City of Hood River in the County of Wasco and State of Oregon have made, constituted and appointed, and by these presents do make, constitute and appoint George P. Growell of said City in the County of Wasco and State of Oregon my true and lawful attorney, for me and in my name, place and stead, meaning for me, Marian S. Henderson, to bargain sell and convey by good and sufficient deeds or to agree to sell or lease, or to mortgage or otherwise encumber, to any person or persons, on any terms or conditions or for any price, as may to my husband aforesaid seem best, any or all of the real property and personal property which I now own or may hereafter acquire severally or jointly with my said husband, or that in which I have a dower interest; and in my name execute any and all deeds, contracts, mortgages, leases or other papers in and about the premises, but all of such papers must be executed also by my said husband to have any force or effect; in other words to stand in my place and do anything in and about the charge and disposition of my property or my interest in my husband's property which I might or could do if personally present and acting for myself, with the distinct understanding that said attorney shall act only as my said husband wishes and entirely as he wishes, and allowing my said husband free control of all my property, my said attorney simply acting with my said husband, and for the special purpose of executing all such legal papers, giving and granting unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes, as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney or his subste-

take. shall lawfully do, or cause to be done, by virtue thereof, and I said John Ireland Henderson join in this instrument for the purpose of authorizing my wife.
