
intersect, pass through or dip into the mining ground or premises hereby granted. FOURTH, That the premises hereby conveyed shall be sold subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes and rights to ditches and reservoirs used in connection with such water rights as may be recognized and acknowledged by the local laws, sustoms and decisions of of Courts, FIFTH, That in the absence of nessery legislation by Congress, the Legislature of Washington may provide rules for working the mining claim or premises hereby granted, envolving easements, drainage, and other nesessary means, to the complete development thereof, In Testimony Whereof, I, Benjamin Harrison President of the United States of America have caused these letters to be made Patent and the seal of the General Land Office to be hereinto affixed.

Given under my hand at the city of Washington the first day of July in the year of our Lord one thousand eight hundred and ninety-two, and of the Independence of the United States the one hundred and sixteenth.
