That at the time of the purchase of the 105.75/±000 acres of land above described the plaintiff was the owner in his own right and as his own separate property and Estate of the sum of one thousand Dollars and that the sum was by him paid for the said Lands and that upon the convexance of the same to him by the said Kinsey Marr the plaintiff on the 5th day of April, A.D. 1884 became the absolute owner of the same in fee simple on his own right and as his own separate property and Estate and that his then wife Louisa Frese took no interest therein whatever and had no interest therein at the time of her death and that the defendants as her heirs at Law or otherwise have no interest therein ord thereto or any part thereof and that the plaintiff is entitled to a decree of the court quieting his title to the same as against the defendants as prayed for in the complaint. It is Therefore cosidered adjudged and decreed that the plaintiff is the owner in fee simple in his own right and as his own separate property and estate of the said 105. 75 acres of land above described and that the defendants nor either of them have my interest or estate therein or thereto or any part thereof whatsoever.

North of Range five East of the Willamette Meridian Washington Containing, one hundred and sixty two acres and twenty four hundredths of an acre acording to the official plat of the survey of the said Lands, returned to the General Land Office by the Surveyor General, which said tract has been purchased by the said Robert Wolf.
