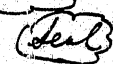
Jacob Ernst Agnes Ernst to F. L. Schanz.

Know all Men by these Presents, That we, Jacob Ernst and Agnes Ernst, his wife, of Bendorf a/Rh. Province of Rheinland, Germany, have made, constituted and appointed, and by these presents do make, constitute and appoint F. L. Schanz, of Portland, in the County of Multnomah, and State of Oregon, United States of America, our true and lawful attorney, for us and in our names, place and stead, to grant, bargain, sell, convey and confirm that certain piece or parcel of land, lying and being in the County of Okanogan, and State of Washington, and particularly described as follows, to-wit:

The South half of the Southeast quarter and the East half of the Southwest quarter of Section Three (3), in Township Two (2) North of Range Six (6) East of the Willamette meridian, containing one hundred and sixty (160) acres, giving and granting unto our said attorney full power and authority to do and perform all and every act and thing whatsoever, requisite and necessary to be done in and about the premises, as fully, to all intents and purposes, as we might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that our said attorney or his substitute shall lawfully do or

cause to be done, by virtue thereof.
