CLAIM OF LIEN

NOTICE IS HEREBY GIVEN THAT J. C. Gaither of Klickitat County, State of Washington claims a lien upon a quantity of white fir and white pine logs being about 60,000 feet in quantity which was cut and manufactured in Klickitat County, State of Washington and are branded with an "R" and are now lying partly in Klickitat County and partly in Skamania County in the White Salmon River in the State of Washington and also a quantity of approximately 130,000 feet of white pine and white fir logs branded with an "R" now lying in the Washougal River in Clark County, State of Washington for labor performed upon and assistance rendered in booming and rafting said logs in White Salmon River; the name of the owners or the reputed owners of said logs are P. A. Griffin and John Doe Meyer, partners; that said P. A. Griffin acting for and on behalf of himself and his said partner employed the said J. C. Gaither to perform said labor and render such assistance upon the following terms and conditions, to-wit: That said P. A. Griffin and John Doe Meyer, partners, acting, by and through P. A. Griffin agreed to pay the said claimant herein for such labor and assistance the sum of 50¢ per thousand for said booming and rafting on said logs; that said contract has been faithfully performed and fully complied with on the part of said claimant and that labor was performed upon said logs and assisted in booming and rafting said logs for a period of approximately 30 days from the date hereof; that said labor and assistance was so performed and rendered upon said logs between the 10th day of September and the 12th day of October, 1938, and 30 days have not elapsed since said time. The amount of claimants demand for said service is \$80.00 and that no part thereof has been paid in which amount he claims a lien upon said logs as above described and claimant also claims a lien upon all logs now owned by said P. A. Griffin and John Doe Meyer, partners and either of them or the said partnership, to secure payment for the work and labor performed in obtaining and securing the said logs, spars, piles or other timber, lumber or shingles herein described.
