

Notice of Location

"Henry" Lode Mining Claim.
Bald Mountain Mining District.
Champania County, State of Washington

The undersigned who is a citizen of the United States hereby declare and give notice to all persons concerned, That he has discovered a vein or lode within the limits of the Claim hereby located and on said lode or vein or vein of quartz or ore with at least one well-defined wall and that he has this nineteenth day of August A.D. 1899 located and do hereby locate and claim under and by virtue of Chapter Six, Title Thirty-two of the Revised Statutes of the United States and the laws amendatory thereof, and the laws of the State of Washington, a mining claim upon said lode or vein to be designated and named the "Henry" Quartz Lode Mining Claim extending along said lode or vein 800 feet in a southerly direction and 700 feet in a northerly direction from the center of the discovery shaft (at which shaft the notice and statement is posted) and 300 feet on each side from the middle or center of said lode or vein at the surface comprising in all 1500 feet in length along said lode or vein and 600 feet in width, with all the rights and privileges as to surface ground and lodes, veins or ledges within the boundaries of said claim and otherwise, and the metals minerals and valuable deposits of every kind contained in said veins, lodes or ledges or within said boundaries which are given or allowed by the laws of the United States approved on or after the date of Washington.

The Mining Claim hereby located is situated in Bald Mountain Mining District, Champania County, Washington and is an Extension of the Blue Jacket Claim on the same land. The adjoining claim is the Blue Jacket on the north. This location is clearly marked on the ground so that its boundaries can be readily traced by a post set at discovery shaft where the notice and statement is posted.

Thence 300 feet in a Westerly direction to post
marked S. W. Cor. Dewey Claim; Thence 1500 feet
in a Northerly direction to post marked N. W. Cor.
Dewey Claim; Thence 300 feet in an Easterly direction
to North Center end post Dewey Claim; Thence 300
feet in an Easterly direction to post marked N. E.
Cor. Dewey Claim, and place of beginning
