

KILGORE TO MARCHBANK AND BLAIR.

LIEN NOTICE.

Fred Blair and F.B.Marchbank. Claimants.

vs

Walter S.Kilgore.Owner.

NOTICE is hereby given that Fred Blair and F.B.Marchbank, of Skamania County, State of Washington, claim a lien upon a lot of sawed fir railroad ties and lumber, said railroad ties being about 500 in quantity being 7x8 " and 7x9" 8 feet long which were cut or manufactured in Skamania County, State of Washington, are unmarked, and are now lying at or near the water tank at Cascades station on the right of way of the Spokane, Portland & Seattley Railway in said Skamania County, Washington, for labor performed upon and assistance rendered in hauling said ties from the mill to the railroad; that the name of the owner or reputed owner is Walter S.Kilgore that Walter S.Kilgore employed said Fred Blair and F.B.Marchbank to perform such labor and render such assistance upon the following terms and conditions, to wit: The said Walter S.Kilgore agreed to pay the said Fred Blair for such labor and assistance the sum of \$1.00 per thousand feet, board measure, for hauling said ties; that said contract has been faithfully performed and fully complied with on the part of said Fred Blair and F.B.Marchbank, who hauled and delivered under the terms and conditions of said contract 64466 feet board measure of said ties which amounted to the sum of \$64.47 and other hauling which amount to \$8.00 making a total earned under the terms of said contract of \$72.47; that said labor and assistance were so performed and rendered upon said railroad ties between the 30th day of March, 1916, and the 25th day of April, 1916, and the rendition of said service was closed on the 25th day of April, 1916 and thirty days have not elapsed since that time. that the amount of claimants' demand for said service is \$72.47; that no part thereof has been paid except the sum of \$1.00 and there is now due and remain unpaid thereon, after deducting all just credits and offsets, the sum of \$71.47 in which amount they claim a lien upon said railroad ties. The said Fred Blair and F.B.Marchbank also claim a lien on all said ties now owned by said Walter S.Kilgore of said county for the work and labor performed in obtaining or securing said ties herein described.
