NOTICE IS HERREY GIVEN that Luke Nichols Company, a torporation, of Clickitat County, feate of Washington claims a lien upon a quantity of white fir and white pine logs being about 60,000 feet in quantity which was out and manufactured in Kilokitat County, State of Washington and are branded with an "R" and are now lyi., partly in Klickitat County and partly in Skemania County in the White Samon Tiver in the State of Washington and also a quantity of approximately 130,000 feet of white pine and white fir logs branded with an "R" now lying in the Washougal River in Clark County, State of Washington for labor performed upon and assistance rendered in towing and assisting in towing said logs from the White Salmon Tiver and the Columbia Diver; the name of the owners or the reputed owners of said logs are W. A. Griffin and John Doe Mayer, partners; that said R. A. Griffin acting for and on behalf of himself and his said partner employed the said Luke Nichols Company a corporation to perform said labor and mender such assistance upon the following terms and conditions to-wit:

That said partners and particularly the said P. A. Griffin agreed to pay to the said Luke Nichols Company, a corporation, for such labor and assistance 65¢ per thousand for all logs towed to Camas, Washington, 95¢ per thousand for all logs towed to Vancouver, Washington and a reasonable sum in addition to the booming and rafting charge for moving said logs in White Salmon viver as might be necessary; that said contract has been faithfully performed and fully complied with on the part of said claimant and that labor was performed upon in assisting and towing and moving said logs by the claimant for the period of approximately 30 days from the date hereof; that said labor and assistance was so performed and rendered upon said logs between the 10th day of September and the 12th day of October, 1938 and 30 days have not elapsed since said time. The amount of claimant a number of said services is \$171.80 and that no part thereof has been paid in which amount he claims a lien upon said logs as above described and chaimant also claims a lien upon all logs now owned by said P. A. Griffin and John Doe Mayer, partners and either of them or the said partnership, to secure payment for the work and labor performed in obtaining and securing the said logs, spars, piles, or other timber, lumber or shingles herein described.
