 payable in 84 installments of \$ 96.62 per month, said installment to be paid on the 10th day
 of each and every month, beginning on May 10, 1962, at office of REYNOLDS ALUMINUM ACCEPTANCECORPORATION, Seattle, Washington, and with interest at 7% per annum after maturity of said. Principal
 and interest payable in legal tender of the United States of America. Maker hereof may pay one or more installment payments prior to due date,
 provided such prepayment is in even multiples of the stipulated monthly installment.If any installment of principal or interest be not paid when due, the holder hereof may at its option declare the entire unpaid balance of principal and all
 accrued interest to become immediately due and payable. Should any installment due hereunder become more than fifteen days in arrears, the maker agrees to
 pay to the holder hereof a "late charge" of five cents for each dollar of said arrearage, but in no case will the late charge assessed exceed \$5.00 or be less
 than \$1.00 in respect to any one delinquent installment.In case suit or action is instituted to collect this note or any part hereof, I (we) promise to pay, in addition to the costs provided by statute, such sums
 as the court may adjudge as reasonable attorney's fees therein, and at the option of the holder hereof the venue of said suit may be laid in King County,

 hereon as a principal, and not as a surety, and agrees to remain bound hereon notwithstanding any extension that may be made to any party liable on this note.


