

Notice of Water Appropriation

Notice is hereby given that Henry Waldo Lee, of Portland, Oregon, claims and appropriates all of the water flowing, being and flowing into and contained in Spirit Lake to the amount of ~~one~~ ^{one} thousand (1000) cubic feet per second.

The purpose for which said water is appropriated is for mining and manufacturing purposes and for supplying cities, towns and villages with water and for water works and the places of intended use are on the Middle Fork of the Toutle River near the West line of Township 9 North, Range 4 East, Willamette Meridian and near the West line of Section 32, Township 10 North, Range 3 East, Willamette Meridian.

The water will be stored in the lake by means of a timber dam which will raise the water to a level ten feet above the high water level of the lake. The water in the lake will also be drawn down to a level twenty feet below the low water level of the lake by deepening and widening the channel at the outlet of the lake. The water will be diverted from Spirit Lake by means of a timber dam at the outlet of the lake in Skamania County, State of Washington in Township 9 North, Range 5 East, Willamette Meridian, and it will be conveyed in a flume and pipe to the places of intended use.
