Notice is hereby given that the above named petitioners has commenced a proceeding against the above named defendants in the above entitled Court for the condemnation and appropriation of a right of way, consisting of a strip of land two hundred feet in width, being one hundred feet in width on each side of the center line of the railroad of petitioners as the same is now located and staked out and in course of construction over and across lots one and two in Section 34 of Township 3 north, range 9 east, of the Willamette Meridian, in Skamania County, Washington, which said center line is more particularly described as follows, to-wit: beginning at a point on the line between sections 33 and 34 Township and range aforesaid, said point being one hundred and seventy-five feet south of the corner to sections twenty-one, twenty-eight, thirty-one and thirty-four, said Township and range, thence southerly on a spiral curve to the right, the forward tangent of which spiral makes an angle of 66 deg. 22' with said section line, - one hundred and ninety-three and six tenths feet to the point of said tangent to said spiral, thence on said tangent to said spiral three hundred and seventy-one and two tenths feet to the beginning of a spiral curve to the left, thence on said spiral two hundred and twenty-eight feet, thence on a curve to the left, having a radius of one thousand nine hundred and ten feet one thousand three hundred and seventy two and two tenths feet; thence on a spiral to said curve two hundred and twenty-eight feet; thence northeasterly on a tangent to said spiral three hundred and eighty five feet, more or less, to the east line of lot two of said section thirty four. The spiral curves in this description referred to are those known as "grades Railroad Spirals". That the object of said proceeding

### Notice of appropriation of Water.

Notice is hereby given that the undersigned, during the course of the rights and priorities provided in Chapter 1411 of Title 1411 Bellinger Annotated Code and Statutes of Washington does hereby appropriate the water being and flowing in and from that stream or creek commonly known and designated as "Little Duck Creek" to the amount of two (2) cubic feet per second of time. Which claim the undersigned does make for himself, his heirs and assigns. The water hereby appropriated to be taken from said stream at or near a place on my homestead being in the North West  $\frac{1}{4}$  of the South East quarter of Section five (5) in Township three (3) North of Range ten (10) East of the Willamette Meridian, in Skamania County, Washington. The water to be taken from said place of diversion by means of ditches, flumes and pipes and lateral ditches flumes and pipes, to back of said  $8\frac{1}{4}$  of Sec. 5. Tp. 3 North of Range ten back W.
