NOTICE IS HEREBY GIVEN that on the 8 day of DECEMBER, 1965,

at the request of MARY DEXING
the above-named claimant commenced to perform labor upon (or to furnish material to be used upon) the following described property consisting of a Single family dwelling

located upon the following described land, to-wit:
in SKAMANIA County, State of Washington,
of which property, the owner, or reputed owner is MARY DEXING

The performance of the labor and material ceased on the 23 day of DECEMBER, 1965.
Said labor (or material furnished) was of the value of SEVENTEEN HUNDRED EIGHTY DOLLARS AND 20/100ths Dollars.

Ninety (90) days have not elapsed since said last named date.

For which labor (or material) the claimant, undersigned, claims a lien upon the property herein described and the buildings situated thereon for the said sum of SEVENTEEN HUNDRED EIGHTY DOLLARS AND 20/100ths Dollars.

Credit was given, the terms thereof being as stated in the following language from a promissory note evidencing the debt:

FOR VALUE RECEIVED, the undersigned, jointly and severally, promises to pay to the order of

CREST ALUMINUM, INC. at the office of the holder, the sum of \$ 1780.20 in installments as follows: 60 successive monthly installments of each of \$ 29.67 except the final installment which shall be the balance due, commencing on February 6, 1966, and the same day of each month thereafter until paid in full. On any amounts unpaid after maturity interest will be at 7% per annum until paid. Principal and interest payable in legal tender of the United States of America.
If any installment of principal or interest be not paid when due, the holder hereof may at its option declare the entire unpaid balance of principal and all accrued interest to become immediately due and payable. Should any installment due hereunder become more than ten days in arrears, the maker agrees to pay to the holder hereof a "late charge" of five cents for each dollar of said arrearage.
In case suit or action is instituted to collect this note or any part thereof, I (we) promise to pay, in addition to the costs provided by statute, such sums as the court may adjudge as reasonable attorney's fees therein, and at the option of the holder hereof the venue of said suit may be laid in King County, Washington.
For value received, each and every party who signs or endorses this note, save parties endorsing without recourse on the reverse side hereof, severally waives presentment, demand, protest and notice of non-payment hereof, binds himself hereon as a principal, and not as a surety, and agrees to remain bound hereon notwithstanding any extension that may be made to any party liable on this note.
