## Claim of Lien--Page Two

The following described real property located in Skamania County, State of Washington, to-wit:

N.W.  $\frac{1}{4}$  and the W $\frac{1}{2}$  of the N.E.  $\frac{1}{4}$  and Gov. lots 2 and 3 all in Section 6-T1N-R6EWM Except that lying easterly of a line as follows: Begin at a point on the north line of Sec. 6 West 20 rods, 17 links from the  $\frac{1}{4}$  corner; thence Southeasterly keeping to the center line of a canyon to its mouth and continuing on the same course to the Cascade road; thence along the Cascade Road 19 rods 15 links West thence in a direct line to the Columbia River taking a hollow Ash stump in the line.

Also except a tract in Gov. lots 2 and 3 as follows. All the portion lying south of the center line of State Highway No. 8 and described as follows. Begin 1320 feet East and 914 feet South of the  $\frac{1}{4}$  corner on the west line of the section; thence N.  $54^{\circ}35'$  East 120.3 feet; thence N.  $71^{\circ}09'$  East 161.7 feet; thence N.  $52^{\circ}48'$  East 863.6 feet; thence East 155.6 feet; thence N.  $62^{\circ}05'$  East 227.8 feet; thence S.  $24^{\circ}45'$  East 228.3 feet; thence S.  $13^{\circ}40'$  East 435.0 feet to the meander line of the river; thence Westerly along the meander line to a point south of the beginning; thence North 498.0 feet to the beginning.
