LIEN FOR LABOR AND SERVICES ON TIMBER AND LUMBER

Donald C. Fleming and Ronald Hackett, Claimants, vs.

Billy Lyons Logging Co.

Notice is hereby given that Donald C. Fleming and Ronald Hackett of Marion County, State of Oregon, claims a lien upon a falling of logs, being about: (1) 790,000 board feet, Rainier Mfg. Co., Rainier, Oregon and (2) 225,000 board feet, Hegawald Lumber Co., Stevenson, Washington, in quantity, which were cut or manufactured in Skamania county, State of Washington, are marked thus: Billy or Ralph Lyons Brand, and are now lying in (1) near Rainier in Columbia River and (2) Hegawald Panther Creek Salvage Sale site, for labor performed upon and assistance rendered in felling said timber to logs; that the name of the owner or reputed owner is (1) Rainier Mfg. Company, (2) Hegawald Lumber Co.; that Billy Lyons Logging Co. employed said Donald C. Fleming and Ronald Hackett to perform such labor and render such assistance upon the following terms and conditions to-wit:

The said Billy Lyons Logging Company agreed to pay the said claimants for such labor and assistance in felling; that said contract has been faithfully performed and fully complied with on the part of said Donald C. Fleming and Ronald Hackett, who performed labor upon and assisted in felling said timber for the period of five (5) weeks; that said labor and assistance were to performed and rendered upon said timber between the 9th day of May, 1967 and the 8th day of June 1967; and the rendition of said services was closed on the 8th day of June, 1967, and thirty days have not elapsed since that time; that the amount of claimants' demands for said service is \$3,337.00; that no part thereof has been paid except \$800.00, and there is now due and remaining unpaid thereon, after deduction of all just credits and offsets, the sum of \$2,537.00, in which amount he claims a lien upon said logs and their proceeds. The said claimants also claim a lien

on all said logs, lumber and staves owned by said Billy Lyons  
Logging Co., Halcyon Logging Co., and Reginald Lumber Co., and  
Rainier Mill Co., to have security of secure payment for the work and  
labor performed in obtaining or securing the said logs, staves, poles  
or other timber, lumber or staves hereinafter described.
