Notice is hereby given: That Louis Carel Zeman of Skamania County, State of Washington, has and claims a lien upon a quantify of fir, larch and white pine logs being approximately 350,000 feet, now lying and being in the Hegewald boom located in Bock Creek in Skaman'a County, Washington, said boom being located at or near the conflux of kock Cresk with the Columbia River in said hock Creek located in Section I, Township Two (2) north of range seven (7) E.W.d. and immediately west of the fown of Stevenson, Washingtor, for labor performed upon and assistance rendered in securing said logs, in yarding and loading the same and in hauling the same from the woods to the said boom, and in fixing the road used in hauling said logs from the voods to the said boom, itemized as follows yarding and loading \$2500.00, hauling \$700.00 and road work \$73.75; that the owner or reputed owner of said logs is R. M. Hegewald. That said R. M. Hegewald employed the said touis Carel Zeman to do said work upon the following torms and conditions, to-wit: that said owner agreed to pay the said claimant herein the sum of \$10.00 per M. for the varding and loading of said logs to pay him \$5.00 per M for the hauling of said logs and to pay him \$9.00 per hour for the work of his cat on the road and to pay \$1.25 per hour for labor on said road; that the contracts and agreements on the part of the claimant have been fully and duly performed and that he commenced with his men and equipment and truck, work in the performance of said agreements about the 25th day of June, 1943, and worked from and after said date to and until the 3rd day of September, 1943, and the rendering of said services ended on the said 3rd dayof Leptember, 1943, during which time the claimant yarded and loaded 250,000 feet of loss which at the agreed price would amount to the sum of \$2500.00; hauled 140.000 feet of logs which at the agreed price would amount to the sum of \$700.00 and worked on the road, with cat 5 hours and a total of his own leoor andhis men, an additional 23 hours, which at the agreed rate would amount to the cum of \$73.75 making a total amount due and owing claimant from said R. M. Hagewald of \$3273.7" no part of which has been peid and said claimant claims a lien upon said logs and the whole thereof for said amount; said claimant also claims property belonging to said 3. 4.
