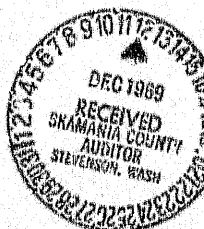

The said SUNSET LOGGING CO. agreed to pay to Claimant for such labor and assistance the sum of \$3.00 per hour for straight time work and \$25.00 per load as a truck driver, that said Contract has been faithfully performed and fully complied with on the part of Claimant, who performed labor upon and assisted in the logging and removal of said logs for the period of November 3, 1969, to November 17, 1969, and the rendition of said services closed on November 17, 1969, and thirty days have not elapsed since said time; that the amount of Claimant's demand for said service is \$376.40, that no part thereof has been paid, and there is now due and remaining unpaid thereon, after deducting all just credits and off-sets, the sum of \$376.40 in which amount he claims a lien upon said saw logs, to secure payment for the work performed in obtaining or securing the said logs, piles or other timber, or manufactured lumber, as hereinafter described.
