### Notice of Water right.

Notice is hereby given that the undersigned, desiring to avail himself of the rights and privileges provided by law for the appropriation of water, does hereby appropriate of the water being and flowing in and from a certain creek, the name of which is unknown, which creek flows in a South-easterly direction through the South west  $\frac{1}{4}$  of Section 14, Township 3 North of Range 9 East of the Willamette Meridian and enters the Little White Salmon River at or near the center stake on the South line of the said Section 14, in Skamania

County, State of Washington, to the extent of Five cubic feet per second of time, which claim the undersigned makes for himself, his heirs, executors, administrators and assigns.

The water hereby appropriated to be taken out at or near the point where this notice is posted, to wit at or near a point about forty rods North-westerly from the point where said creek enters the said Little White Salmon River, as aforesaid.
