## Notice of Water Right

Notice is hereby given that the undersigned claims the water being and flowing in the Panther Creek to the extent of 700 cubic feet per second of time for irrigation and domestic purposes to be conveyed by ditch, flume or pipe from their point to turn off through upper & lower Valley in Shumway County, Washington. This notice is posted on or about the intended point of diversion on the Panther Creek West side of a point Panther Creek 4500 feet more or less above the old logging dam and bridge posted on a large cedar tree west bank of Panther Creek, blazed on 4 sides.
